Good News

The following "Good News" items were shared:

- Mrs. Downing's 5th grade class received an \$895 grant from Panora Teleco to purchase flexible/alternative seating options such as standing desks, stability balls, and stools.
- Panorama FFA competed in their first round of leadership contests for teams and individuals in December with six out of eight events moving on to district competition.
- For Christmas, every Panorama elementary student received a new book as a gift from the Panorama PTO.
- Elementary students at Panorama and West Central Valley participating in the Food Bank of Iowa Back Pack program
 received a new book. This was possible through the combined efforts of The Twisted Bean Coffee Company's Christmas
 book drive and donations from the Panorama staff.
- Ben Marwedel received a perfect score of 36 on the ACT test.
- The Panorama HS Boys basketball team was featured on KCCI Channel 8 with a story about their annual tradition of serving a meal to the Girls' basketball team.

Reports

Liz Ratcliff, Elementary Principal

- During the second semester, the elementary will continue to focus on the Common Core Standards and will work on "what" we are teaching as well as "how" we are teaching.
- The Teacher Leadership team will continue to provide opportunities for peer reviews and will focus on lesson plans and how teachers are delivering instruction.
- The CSI Team (Committee for Strengthening Instruction) will focus on instructional practices and engagement strategies. This team will also look at ways to support students during the lowa Assessments.

Thad Stanley, MS/HS Principal

- The Multi-Tiered Student Support (MTSS) group met on January 4, 2017 and reviewed the new guidelines to determine which students will report to either a Math or Reading intervention program.
- The District Teacher Leadership Team will continue to create professional development activities to move towards the
 instructional shifts within the education program at Panorama. These instructional shifts are more about the way students are
 taught based on best teaching strategies.

Shawn Holloway, Superintendent

Mr. Holloway has been working with IT Director Cindy Christe on a five-year PPEL plan for technology. This current plan does
not support a 1:1 initiative. With this plan, the district would lease technology solutions and have several mobile labs available
at the school for students and teachers to access. If the board would like to pursue an actual 1:1 environment, then
alternative technology solutions will need to be evaluated. More discussions will take place in the future.

KUNO Settlement

The district received \$131,578.34 from the KUNO settlement. The district still owes one additional lease payment in the amount of \$90,000 that will be paid this summer.

2017-18 Negotiations

The district will begin negotiations with the Panorama Education Association (Teacher Union) in the next couple of months. Board members Deb Douglass and Deborah Westergaard will participate in these negotiations on behalf of the board of education. The district will not negotiate with LiUNA (Bus Driver Union) this year as a 3-year agreement was reached last year.
