Call to Order

The Panorama Community School District Board of Education met for a regular meeting on June 12th, 2017 in the district board room located at the middle/high school. The regular meeting was called to order by Bryice Wilke, President, at 6:30 pm.

Good News

- The girls track team placed in 4 events at the state track meet to earn a tie for 15th place; which is the highest finish in class 2A in school history. The girls had 16 athletes in 10 events at the state track meet with Lydia Knapp placing 7th in the discus, Devyn Kemble placing 4th in the 400 and Morgan John placing 5th in the high jump and 4th in the 100m hurdles. The shuttle hurdle relay placed 9th, the sprint medley relay placed 9th and Devyn Kemble placed 10th in the 800.
- The boys track team placed in a tie for 37th with 5 points from Matt Webner's 4th place in the discus. A total of 3 boys competed in 3 events at the state track meet.
- Congratulations to the Boys Golf Team on their 3rd place finish at the 2A State Golf Tournament this past season. Will
 Babcock and George Appleseth were named first team all-state, and Kolby Shackelford was voted onto second team all-state.
 Coach Hal Rossow was also recognized on this date as the 2016-17 National Coach of the Year. M. Wilke thanked Hal
 Rossow for his 38 years of service for the district.

Reports

Liz Ratcliff, Elementary Principal & Thad Stanley, MS/HS Principal

Mr. Stanley and Mrs. Ratcliff provided the lowa Assessment Data for Panorama Schools for the 2016-17 school year. This report showed the percent of students scoring proficient in reading, mathematics and science. Results show that more focus is needed in reading and math throughout all grade levels at Panorama.

Shawn Holloway, Superintendent

- The district has advertised for a 2nd Spanish teaching position. The district did not receive any quality candidates from lowa, therefore the district is currently seeking a teacher from Spain through the Department of Education.
- The district has advertised for a Director of Maintenance due to the resignation of Sterling Stoppelmoor. A recommendation to address this open position will be brought forth at the July board meeting.
- The lowa Association of School Boards has completed a review of the district's board policies. Mr. Holloway will begin working on needed updates/changes and will bring recommendations to the board in future meetings.

Discussion/Information Topics

Soccer Program

Update from Sub Committee (Jaime Waddle)

Jaime Waddle was present representing a committee that included school staff as well as community members. The committee was formed as recommended by the board to explore the aspects of a successful and sustainable soccer program. The committee's recommendation to the board was to adopt a soccer program at Panorama for both boys and girls to be played as a spring sport.

Information from Current Coaches (Greg Thompson)

High School Track/Cross Country Coach Greg Thompson was present representing a group of 5 Panorama coaches. Mr. Thompson expressed concern with the recommendation to add soccer as a spring sport for a variety of reasons. Mr. Thompson stated that these coaches were not against soccer, they just believe it should be maintained at the recreational level.

- Deb Douglass stated her concern with the student survey shared by the soccer committee and requested more specific data in regard to participation and how other spring sports may be affected. She also recommended that Panorama discuss the possibility of sharing a program with AC/GC.
- Byrice Wilke expressed his concern with the long term sustainably of the program.
- Mr. Holloway stated that he will initiate a formal survey as well as schedule a meeting with AC/GC. He will provide more
 information to the board at a future board meeting.
