#### Reports

## Liz Ratcliff, Elementary Principal:

-Curriculum & Instruction – Elementary held their first Data Days for literacy & math after FAST Screening. AEA consultants met with grade level teams to analyze student data. Staff collaborated and planned instruction based on student needs & strengths as whole groups, small groups and intervention/enrichment time.

-Elementary Lead Team Presentation by Aly Dahlhauser & Kelly Blomquist – K-5<sup>th</sup> teachers spent time reviewing current reading instructional materials to see what is needed to reduce the gap in students reading skills. They noticed students struggling with reading in the older grades were lacking phonics foundational skills. Teaching phonics at the kindergarten level and continuing with a supplemental phonics program at the 3<sup>rd</sup>-5<sup>th</sup> grade level (West Virginia Phonics) will help bridge the gap in students reading skills.

## Thad Stanley, MS/HS Principal:

-First round of peer to peer observations with staff completed (P.O.P) focusing on the Iowa Instructional Framework. The focus for the middle school and high school is the climate and culture piece (Environment and respectful culture).

-All day professional development is planned for November 15<sup>th</sup>, 2019. District wide staff will do ACES (Adverse Childhood Experiences) Training learning how to identify experiences and strategies to mitigate toxic stress response. With the help of the AEA, staff will also start de-escalation training on how to better deal with certain student behaviors and the best strategies to use that will allow that student to have success. District staff will also do suicide prevention and postvention training.

-Guthrie County Hospitals visited students and did a presentation on Stomping Out Bullying, Healthy Choices and Vaping. This was an informative discussion reminding students to make good choices in how they treat each other, self-health and the dangers of vaping and the body.

# Shawn Holloway, Superintendent:

-October 15<sup>th</sup> Superintendent Holloway will present to the SBRC regarding spending authority request to recoup the unforeseen increased electricity expenses.

-2019-2020 Certified Enrollment complete and overall, enrollment is stable.

-SIAC will meet October 15<sup>th</sup> covering the district financial overview and a conversation facilitated by Ann Appleseth on ways to improve communication protocols.

-End of FY19 PPEL & SAVE balances shared and initial work on the PPEL/SAVE summer 2020 projects and beyond has started. - Final FY19 Unspent Balance Report reviewed with the board, 97.6% of authority spent for FY19.

-Statewide Special Education Enrollment Growth in the last 3 years for the state of Iowa has increased. Mr. Holloway shared the Panorama Special Education Deficit History for these last 3 years and explained it is one example of why the deficit is hard to predict.
